

Your Medicare Checklist

Here's what you can do to get prepared during your Initial Enrollment Period - the 7-month period surrounding the month of your 65th birthday:

4-6 months before you turn 65


- Talk with your employer** to see if your current insurance will change at age 65.
- Learn the Medicare basics** – What are the parts of Medicare? What do they cover? How much will I pay?
- Contact Social Security** to make sure you know when you're eligible to enroll in Medicare Parts A and B.


1-3 months before you turn 65

- Enroll in Medicare Parts A and B** before you turn 65 so that you don't have a lapse in coverage.
- Look at options that give you more coverage** than Original Medicare alone, like Medicare Advantage plans.
- Check with your doctor(s)** to see if they accept different types of Medicare coverage.
- Check your prescription drugs** to see if they're covered.
- Sign up for Medicare Advantage.**
