¹ Plan A and Plan B are available to those who are under age 65 and qualify for Medicare due to disability.

² Plans F and G also have a high deductible option which require first paying a plan deductible of \$2,870 before the plan begins to pay. Once the plan deductible is met, the plan pays 100% of covered services for the rest of the calendar year. High deductible plan G is only available to those first eligible for Medicare on or after January 1, 2020, and does not cover Medicare Part B deductible. However, high deductible plans F and G count your payment of the Medicare Part B deductible toward meeting the plan deductible.
