Products Affected: Albuterol HFA, Proventil HFA (albuterol); Ventolin HFA (albuterol); Xopenex HFA (levalbuterol); ProAir digihaler (albuterol)

Medication Description: Albuterol is an inhaled, moderately selective short-acting beta-2-receptor agonist (SABA). Albuterol is a racemic mixture of R- and S-isomers, and is widely used as a bronchodilator.

Covered Uses:

1. Treatment or prevention of bronchospasm in patients 4 years of age and older with reversible obstructive airway disease
2. Prevention of exercise-induced bronchospasm in patients 4 years of age and older

Exclusion Criteria: N/A

Required Medical Information:

1. Diagnosis
2. Previous medications tried/failed

Coverage Duration: 12 Months

Other Criteria:

- A. Patient has had a trial and failure of ProAir HFA or ProAir Respiclick, defined as

 - a. Allergic reaction; **OR**
 - b. Adverse drug reactions
