Effective: January 1, 2020

Prior Authorization: Topical Antibiotics

Products Affected: Centany 2% ointment, Centany AT 2% ointment, Altabax 1% ointment, Bactroban 2% nasal ointment, Xepi 1% cream, mupirocin 2% cream

Medication Description: Topical antibiotics are antibiotics that have been made into a cream or ointment that can be applied directly on the skin. These medications work by inhibiting bacterial protein synthesis.

Covered Uses:

1. Nasal colonization with methicillin-resistant *Staphylococcus aureus* (MRSA) – Bactroban Nasal Only*
2. Impetigo due to susceptible isolates of *Staphylococcus aureus* and *Streptococcus pyogenes*

Exclusion Criteria: N/A

Required Medical Information:

1. Diagnosis
2. Previous therapies tried/failed

Age Restrictions:

Bactroban nasal ointment: 12 years and older
Centany, Centany AT ointment: 2 months and older
Xepi cream: 2 months and older
Mupirocin cream: 3 months and older
Altabax ointment: 9 months and older

Prescriber Restrictions: N/A

Coverage Duration: 12 months

Other Criteria:

Bactroban Nasal

1. Patient has a diagnosis of nasal colonization with methicillin-resistant *Staphylococcus aureus* (MRSA); AND
2. Patient has a documented intolerance, contraindication, or treatment failure with, an adequate trial of mupirocin 2% ointment

Centany, Altabax, Xepi, mupirocin 2% cream

1. Patient has a diagnosis of impetigo; AND
2. Patient has a documented intolerance, contraindication, or treatment failure with, an adequate trial of mupirocin 2% ointment
